hanks to the cooperative principle of "Cooperation Among Cooperatives," Corn Belt Power's service territory

now has a fully functioning battery energy storage system as of Aug. 29.

Basin Electric Power Cooperative, which provides power to electric co-ops across the Midwest, introduced a member-owned Trial Battery Rate into its rate book in 2019. The rate allocates up to 150 kilowatts per Class C distribution cooperative.

Corn Belt Power, a Class
A member of Basin Electric,
collaborated with our membership to develop
a plan that allows each member-cooperative
to pool its individual allocation and create
one large battery energy storage system. This
system is a 1.425 megawatt Tesla® Megapack
which Corn Belt Power integrated into the

Hampton Substation.

Total project cost is near \$3.5 million, which includes the battery pack, engineering,

site preparation and labor. The stored power from the battery will allow Corn Belt Power to avoid purchasing 1.425 megawatts of power during peak usage times for up to six hours. This is enough energy to power roughly 145 homes for six hours at a time.

Once the battery's energy is depleted, it will recharge during off-peak times in preparation for its next disbursement.

"We want to learn more about battery technology, from the process of procuring and installing the batteries to operation and how the batteries can benefit the co-op," said Jacob Olberding, vice president, power supply, Corn Belt Power. "We will also use the battery project as a load management resource. By doing so, we hope the batteries pay for themselves in 12 years."

Corn Belt Power plans to share ongoing performance data with its membership to highlight the battery's

ability to reduce member-cooperative power costs and use existing generating resources more efficiently. This sharing of operational information will provide the membership with education and insights to support future use of battery storage technology.



orn Belt Power Cooperative marked the 75th anniversary of its articles of incorporation with a celebration at the Humboldt County Fairgrounds Thursday, August 25.

More than 200 employees, retirees, directors, member system managers and special guests attended.

"Our founding day actually took place August 28, 1947," said Ken Kuyper, executive vice president and general manager, Corn Belt Power in his welcome remarks. "I could go on and on about Corn Belt Power history. But, by and large, I would be preaching to the choir. You all know our story, about how we helped play a role to pull rural Iowa out of the dark in the 1930s and 1940s."

Kuyper thanked those in attendance for their steadfast dedication to Corn Belt Power's mission.

"This achievement can be attributed to individuals with far-reaching vision who created the cooperative 75 years ago and to the dedicated people since that time who have worked to make it strong," he said. In 75 years, Corn Belt Power has grown as a power supplier to more than 34,000 homes, farms and industries and 20,000 municipal customers. The cooperative maintains more than 1,790 miles of transmission line, 160 substations and 46 switching stations across 41 of Iowa's counties.

# Ward inducted into Hall of Fame

etired cooperative attorney John Ward will officially be inducted into the Iowa Institute for Cooperatives' Hall of Fame at the IIC annual meeting in November.

IIC established the Iowa Cooperative Hall of Fame in 1999. Since that time, 51 individuals have been selected to receive this award. This distinction recognizes the extraordinary service to Iowa cooperatives provided by these individuals throughout the course of their public and private lives.

During his 56-year career at Sullivan & Ward, Ward served as legal counsel for several of Iowa's electric co-ops and attended more than 500 cooperative annual meetings before retiring in 2020.

Specifically, Ward served as counsel to many electric generation and transmission utilities and distribution cooperatives across America in the development of power supply and transmission arrangements and agreements. He has also provided primary representation of electric utilities in the development of financing agreements with Rural Utilities Service (RUS), National Rural Utilities Cooperative Finance Corporation (CFC), CoBank and other lending institutions to build and develop power supply and transmission facilities.

"I can't think of a better cooperative leader and person than John to receive this honor," said Ken Kuyper, executive vice president and general manager, Corn Belt Power. "John was a staple in our board room for many years and was instrumental in so many things Corn Belt Power was able to accomplish." ■
